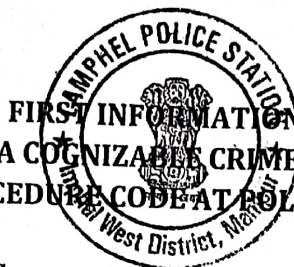





That today i.e 11/5/2023 at about 9:30 am, one R.K Umakanta Singh, aged about 41yrs of Sagolband Moirang Leirak who had taken a sum of Rs. 1,00,000/- (Rupees One Lakh) only has assaulted me severely by using a deadly weapon at the first floor of Laiphamkhunou Hyundai Office on requesting him to return back my money. As a result of which, I received severed injury at my head. Thereafter the incident, I was immediately evacuated at JNIMS hospital for medical treatment.
