Subject: Complaint report.

I am to state that, on 4th May 2023 at about 3: 00 pm, our locality Khongsai Veng, Laipham Khunou under Lamphel Police Station (Imphal West and falling under revenue of Imphal East) was under mob attacked by the companion of the lambda of the lamb under mob attacked by thousands of unknown miscreants belonging to the Meitei community with criminal intention to community with criminal intention to cause damage of property and life. They were armed with deadly weapons including automatic ride.

As a result, many houses and properties worth crores were destroyed and burnt to ashes. including automatic rifles, SBBL, knives, etc. Among which my house No. 76 (rent) was also destroyed by the mob, many properties were burnt and leftovers were located

Lists of properties (both immovable & movable) looted, burnt and destroyed are given and leftovers were looted.

2. Furniture includes 1 wooden Almira, 2 Wooden beds, one Sofa sets, one dressing table, one TV stand 2 jumbs hav stand,2 jumbo box.

3. 2 bags of rice.

- 4. Traditional ornament includes- Two necklace (Khiba).
- 5. One Misao Gas connection, cylinders-3 nos and 1 stove.
- 6. Electronic items- 1 Television, 1 Fridge, 1 Washing machine.

7. Cash-30,000/-

8. Documents-Educational certificates (Matriculate to Graduate)

9.Misc.

The approximate total loss of properties would be Rs 15 Lakhs.

It is, therefore, kindly requested to take necessary legal action to arrest the culprit involved in the incident at the earliest in the interest of justice. I hereby lodged my complain at Kangpokpi Police Station as I had fled from my residence to safe myself and my families from the rioters.
