To the incident, all my properties at my Government Quarter No. 1 Type III Air Complex, Lamphelpat were ransacked, resulting in destruction or looting.

Details of my properties loot in the act are as under.

- 1. Furniture: 1(One) sofa set, 2(Two) beds, 1(one) gas box, 2(Two) study tables, 1(One) dining table and 2(Two) almirah Godrej.
- 2. Electronics: One TV(42 inch), 1 Hp Desktop, 1 Samsung Smartphone, One refrigerator(200L), Washing machine.
- 3. Kitchen items: one gas stove, four gas cylinders, Kitchen cabinet utensils.
- 4. Traditional wears and Ornaments: One Dahpi(Gong) 40 inch. Two Khibas(Beads), 30 Saipikhup Shawls.
- 5. Personal Clothing: Seven pairs of men's shoes, ten pairs of women's shoes, 10 jean pants, 30 T-Shirts, 10 kameez shirts.

The estimated value of my property lost in the incident is around 16 Lacs.
