Whereas, to save our head, my family and I barely managed to escape our home. We were lucky enough to be pick up by the Indian Army to a safe zone, and to the extend that we were unable to pick up even a needle as a household property.

As, I report to you, my properties worth more than 3,50,000/- appx. Including an RC Book bearing Regn. No. MN01AS7046 (Tata Safari) has been burnt down to ashes by the violent mobs.
