

Sir,

With due regard, I the undersigned have the honour to state few line for your kind consideration and needful action.

That, today i.e 12/5/2023 at about 12.30 pm, one Danial L. Hmar, aged about 45 yrs S/o Late. Lalthangmoia Hmar of Sangaiprou Mamang Leikai who is my neighbour serving in CRPF as an Assistant Commandant and posted at 86th Battalion CRPF Lamphel had come to my house unexpectedly with his CRPF escort teams including one non-local Inspector in full uniform with arms had brutally assaulted my younger brother namely Tokpam Malemnganba @ Naoba, 29 yrs under the influence of intoxication. Further, (Danial L. Hmar) has also threatened to killed our entire family by showing their arms. As a result of which my younger brother received severed injury on his head and other part of his body. Later he was evacuated at Raj Medicity for medical treatment. Moreover, there is an apprehension to my family that he might harm my family in future.

Therefore, I request you to kindly take necessary action against Danial L. Hmar with one Inspector and others arms CRPF associates. Thanking you for your kind co-operation.
