

In the process, they have stolen my 2(two) wheeler vehicle namely TVS JupiterZX Intelligo (Starlight blue) bearing Registration Number MN06SF 6507, Engine No. EG5LM3301243 and Chassis No. MD626CG55M3L39683 which was parked in our verandah.

I therefore request you to take up necessary legal action regarding the incident.
