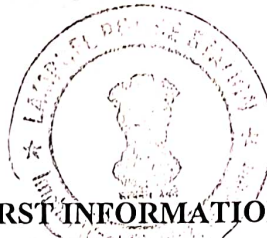



Subject: First Information Report (FIR) on property damages and burnt down.

Sir,

I am Mrs Lhaitinchong Chongloi W/o Kaiminthang Chongloi, resides at Meitei Langol, Imphal West, Manipur. On the fateful day of 4<sup>th</sup> May, 2023 at around 4:00 P.M, hundreds of violent mobs with sophisticated weapons carrying iron bar, wooden sticks, some with machete attacked our residential areas.

Whereas, to save our head, my family and I barely manage to escape our home, we were lucky enough to be picked up by the Indian Army to a safe zone, and to the extend that we were unable to pick up even a needle as a household property.

As I report to you, my properties worth of Rs. 3,50,000/- approximately has been burnt down to ashes by the violent mobs.
