Subject: Lodging of FIR

Sir,

With due respect, I would like to inform you that on 4th May 2023 at around 9:30 pm some valley-based organisations to be volunteers of Arambai Tenggol, Kangleipak Kanba Lup (KKL), Meitei Leepun, numbering around 500, broke into my residential quarters at National Games Village, D-150, Zone-2 with an attempt to kill us however I along with my family managed to escaped and they looted all my household properties worth approximately around 60(sixty lakhs) only, which includes very important educational documents of my family, valuable electrical gadgets, a Maruti Alto Car which has been burnt down by the suspected volunteers of the above organisation. All the household furniture's and appliances were also looted by them.

I therefore request you to take up necessary legal action regarding the incident.
