With due respect, I would like to inform you that on4th May 2023 at approvide 59.00 pm some valleybased organisations suspected to be volunteers of Arambai Tenggol, Kangleipak Kanba Lup (KKL), Meitei Leepun, numbering around 500 broke into my quarters at Langol Housing Complex, Type-III, E-59 with guns with an attempt to kill us while I along with my family managed to escape and they looted all my household propertie sand burnt down the following vehicles of my family:

- 1. TVS Jupiter bearing Regn No. MN06SC 5534 (purchased from Yaima Store Khojathong)
- 2. Activa 4G bearing regn No. MN01AD 9107 (purchased from Yaima Store Khoyathong)
- 3. Royal Enfield 350 Classic (purchased on loan from Sanamahi Motors Khoyathong)
- 4. Royal Enfield bearing Regn No. MN01AM 0068 (purchased on loan from Paul Motor Cycle Cgurachandpur)
- 5. TVS N-Torg (purchased on loan from Khoyathong TVS Store Imphal) and
- 6. Maruti Brezza bearing Regn No. MN01AW 1267 (purchased on loan from Eastern Motor Chingmeirong)

The household properties also include valuable electrical household gadgets and valuable personal documents. The total worth of all the household properties including the said vehicles is approximately around 70(seventy lakhs) only.

I therefore request you to take up necessary legal action regarding the incident.
