



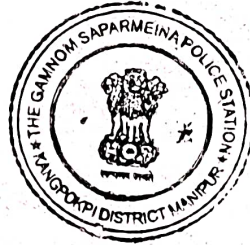

I, the undersigned would like to raise a complaint against a group of miscreants. The incident happened on 04/05/2023 at around 11:00 am, where a group of miscreants numbering more than 1000 attacked my house situated at Langol Housing Complex C/17 Type II. I along with my family had a narrow escape and ran for our lives. But the group of miscreants vandalize my house and also looted all my household properties.

The looted and destroyed properties is estimated at Rs. 80 Lakhs approx.

I could not report the incident to my concern Police Station as well as in time due to the prevailing law and order situation in the state.

I, therefore request your good Office to kindly take necessary action in this regard
