



Subject: Report.

Sir,

With utmost respect, I the undersigned have the honour to state few lines before you for your kind consideration and necessary action.

That, on 4th May 2023 at around 11:00 am, unknown miscreants led by Arambai Tenngol, Meitei community, suspected to be members of, Kangleipak Kanba Lup, Meitei Leepun and Meitei mobs of around 800-900 people looted and burnt down my house and properties, household furniture, important documents, vehicle MN01X-6875Santro Xing 2012 Model, cash and jewellery at Lamphel Supermarket. PO & PS – Lamphel which the cost is estimated to be around 2 crores.

Also, Mushroom processing Machinery taken under Vijaya Bank Imphal City, MG Avenue as loan was also looted and burnt down which the estimated cost was Rs. 15,30,000/- (Fifteen lakhs and Thirty thousand only). The list is as follows :

1. Baby Boiler - Rs. 2,00,000/-
2. Tray Type Dehydrator - Rs. 10,00,000/-
3. Can Seamer -Rs. 50,000/-
4. Can reforming - Rs. 30,000/-
5. Exhaust box - Rs. 50,000/-
6. Steam jacket Kettles - Rs. 50,000/-
7. Weighing Machine, etc - Rs. 1,50,000/-

Rs. 15,30,000/-

I could not report the incident to my concern Police Station as well as in time due to the prevailing situation in the state.

Therefore, I, request your good office to take up necessary action in this regard.
