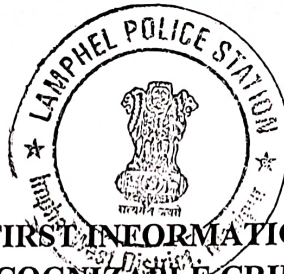





Today i.e. 26/07/2023 at 2:15 pm, received an information from SP-IW control room that on same day at around 2:00 pm, one Maruti Alto Car (Dark Blue in colour) bearing Regd. No. MN02G-2824 driven by unknown driver coming from Uripok side towards Iroisemba and one Honda Activa 6 G (Blue in colour) bearing Regd. MN06SD-5940 ridden by unknown rider coming towards Uripok side collided each other at Samusang Uku, due to rash & negligent driving on the part of the both driver and rider. As a result of which the unknown rider of the Honda Activa received injury on his left leg and evacuated to RIMS Hospital for medical treatment. However, the driver of Maruti Alto car escaped from the spot. The Maruti Alto Car and Honda Activa got partly damaged on its front part.

Hence, a regular Suo-Moto case under FIR No. 1080(7)2023 LPS u/s 279/338/427-IPC has been registered for investigation.
