





Unfortunately my rent house and properties located at the above mentioned address had been completely burnt down on the 4th of May 2023 by unknown mob uprising (around 1000 persons). I have enclosed the details of my household items/properties destroyed by the mob. I could not report the matter at the earliest due to my official duties and the transport and communication problem prevailing in the law and order in our state, Manipur.

Further, I humbly request you to kindly take up the necessary action. I shall ever remain thankful to you for your kind act.
