Subject: Report of destruction and loss of household materials of my residence (rented) located at Khugatampak, Meitei Leikai under Churachandpur Police Station.

Sir,

I, Most humbly like to report that my residence which I had rented from N. Binoy Meitei of Khugatampak, Meitei Leikai has been burnt down into ashes and also looted by a group of armed miscreants belonging to Kuki community numbering about 1000-2000 people on the evening of the 3th May, 2023 at about 8:30 pm, along with gun and intend to kill all my family members.

I and my family provided shelter at Tuibong Mini Secretariat under the guard of armed security personnel, wherein I stayed from early morning of 4^{th} May 2023 till 9^{th} May 2023 and then shifted to a relief camp in Konjengbam Leikai, Moirang Bishnupur District.

I have provided a list of items that I have lost and its approximate value in this application. I would like to request you to kindly do the needful as per the law of the land.

List of items lost and their approximate value:

1. Samsung Laptop- Rs. 40, 000/-, 2. Sofa Set- Rs. 10,000/-, 3. T.V- Rs. 15,000/-, 4. Almirah- Rs. 8000/-5. Washing Machine -Rs. 10,000/-, 6. Refrigerator- Rs. 15,000/-, 7. Apparels- Rs. 20,000/-, 8. Cash-9000/-, 10. Bed & Mattress – Rs. 20,000/-. The total amounts Rs. 1,55,000- approx.

Due to uncertainty of the situation in churachandpur, the communal crisis and my inability to find a proper place to stay, the application has been delayed.
