Subject: Complaint report.

On 4th May 2023 at around 12:45 pm, my quarter (CP-4, Type-7) at Lamphel was attacked by hundreds of unknown miscreants belonging to the Meitei Community.

The mob tried to enter the quarter after throwing stones, hitting with iron rods, axes, long knives, etc. but the house-guards (of 2-MR) held on and also fire several live rounds numbering 60/70 rounds. During that time, I along with several officers including SP/IW managed to reach and help disperse the violent mob.

The mob attacked destroyed one CCTV camera, windshields and side glasses of 5 vehicles parked inside, damage to the gate, and partial damage to the sentry post also.

You are therefore requested to take up necessary legal action.
