Dear Sir/Madam,

My name is Hoiting Vaiphei a resident of PaiteVeng, Sangaiprou, Imphal-west, Manipur.

I am lodging this complain against an unknown miscreants/mobs for attempted murder, looting and burning of my properties and valuable documents. These heinous crimes have left me and my family members in a trauma and unsafe in the state of Manipur. I am currently staying in New Delhi.

The incident took place on 04/05/2023 between 11:00 a.m and 12:00 noon at K.R Colony, Behind FCI/FCS Godown, Sangaiprou, bearing Patta No.279 (old) corresponding to new Patta No. 916/2396 covered by CS Dag No. 1113/2649 measuring an area of 0.03845 acre which is situated at Revenue village No. 83-Lamjaotongba Gram Panchayat of Patsoi Sub-Division, Imphal-West, Manipur-795001 where I am constructing a residential building by obtaining a bank loan from SBI, M.U. Canchipur Branch and from my personal saving. These miscreants/mobs attacked, looted and burnt all the construction and building materials which were kept in a store house inside the compound of my property.

My property was subjected to a horrific act of vandalism, where miscreants/mobs broke into my property and looted all of our valuable possessions as mentioned above (i.e construction and building materials and Iron Gate). The perpetrators also set fire to my store house, causing extensive damage and rendering it to ashes. This has not only caused financial loss, but also emotional trauma for me and my family and the loss will not be able to recover for the rest of my life. Now I'm left with nothing as I have to run for my life and had a narrow escape from death. This horrible incident has had a profound impact on our lives, and we feel violated and unsafe in our own homes and I hold the authorities responsible for not providing adequate security measures to prevent such gruesome attacks from occurring.

I urge you to take swift action to bring these criminals to justice. I request that you launch a thorough investigation into the matter and bring the culprits to book. I request you to take this matter seriously and to act swiftly to ensure that justice is served.
