Subject:- Complaint for grievous injury and mental harassment.

Sir,

With regards to the above mentioned subject, I would like to lodge a complaint regarding grievous bodily injury and mental harassment inflicted on me by the personnel of Gorkha Regiment who are posted at Zone-I Police Church, Game Village. The sequence of events that leads to my present complaint is provided below:-

## Sequence of events:-

- 1) On 21st July, 2023 at around 9 AM, I returned from JAS Petrol Pump, Uripok with 2 litres of petrol in a bottle (for emergency use) back to my residence at Game Village, Langol. I was stopped at the junction of Zone-III and Zone-IV by a team of Gorkha Regiment who are posted at Zone I, Police Churh, Game Village. When they asked me what the petrol was for, I informed that it was for emergency use. I also identified myself that I was a Court staff presently posted at Special Court (ND&PS), Manipur at Lamphelpat and also showed my official ID and Aadhar card. However, they detained me and told me that the petrol I was carrying was illegal and arrested me and then handed me over to local police personnel who were stationed at Game Village. However, the local police personnel, after enquiry released me stating that I had done nothing illegal.
- 2) On 25th July, 2023 at around 10.30 AM, I left my official quarter for office. The same team of Gorkha Regiment then stopped me and conducted checking of myself and my vehicle. I can identify some of the personnel of the Gorkha Regiment who stopped me. I also produced my Office ID as

well as my Aadhar card to prove my identity. After the said checking, I requested them to hand me my office ID and my Aadhar card as I was already running late for office. However, they shouted at me using abusive language. Two personnel of GR then attacked me by punching my on my face multiple times and also hit my leg and arm using a log of wood. I can identify the personnel who assaulted me on the said day. After that, they let me go to office after threatening me that if I behave like this again, that they will kill me, exact words being "tu phir se aisa karega to upar jayega" by pointing a finger towards the sky.

- 3) On the next day, i.e., 26th of July, 2023, at around 12.10 PM, I left my quarter to go to AG Office to collect the Pay Slip of Judge, Special Court (ND&PS), Manipur when the same team of GR personnel who were coming from their check-post suddenly stopped me again on the road and proceeded to conduct checking and frisking of my vehicle while letting everyone else go. They then again asked for my details which I gave them willingly including my mobile number and my residential address including Quarter Type/No. When I inquired as to why they needed my details, they informed me that they will come to my residence anytime and will also call me anytime.
- 4) On 27th of July, 2023, at around 10.34 am, I got a call from an unknown number being No. +91 1246914720 who spoke in Hindi and asked me whether I was Anthony. I answered that I didn't know Hindi and asked the person who he was (in Manipuri). Before answering, the person disconnected the call. Again at around 11.01 am of the same day, I got another call from another unknown number being No. +91 124 6941 4616 and asked me the same question. I answered like before and he disconnected the call. I can identify from the voice that the said calls were made by one of the personnel of GR.

5) I suffered severe body pain due to the assault by the personnel of GR and I was medically examined at RIMS Hospital, Casualty Ward on 27.07.2023 (Medical document enclosed).

The above said acts of the personnel of Gorkha Regiment posted at Zone I, Police Church, Game Village have not only inflicted physical pain to me but also caused mental trauma and harassment to me and as such, I want your good self to take necessary legal action against them.
