2. That, I was informed overphone at about 5.48 am by Rev. Aphang Pastor Tangkhul Baptist Church, D Sector of Langol Housing Complex that my residential Government Quarters detailed above in the subject had been burnt down to ashes by unknown miscreants at the wee-hours of 5.6.2023(Monday) and that they in great numbers, despite hard effort could not save it all on account of shortage of water.
