That, I run the business of Gold Mortgage and consultancy Service at the above mentioned premises.

That, during communal riot, on 4th May, 2023 innumerable unknown persons with knife and weapons broke into the said office and burnt also looted the properties including Tables, Chairs, Almirah, Wall Clock, Stand Fan, Water Filter, CCTV cameras along with Machine, Gold ornaments and Cash etc.

That, I have irreparable loss in my life due to the unfortunate incident.

It is therefore requested to investigate the matter to get relief and compensate the victim.
