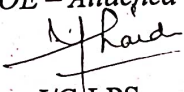

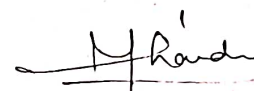

I am to state that on the 7th May, 2023 at about 12 Pm our locality AIR Colony, Kamphel and near by Quarter was under Mob attacked by a thousand of Miscre ants belonging to valley base Meitei Community organisation called Areambai Tengel group, World Meitei Council and Meitei Keipum with and intend to kill all my family members.

As a result many houses and properties was destroyed and burnt to ashes by the and left over looted. Total losses of my properties would be about Rs-12000000/- (Twenty Lakhs) approximately, without any reason is highly condemnable and totally uncon for booking of the culprits under appropriate section of the Indian Penal code.

I, therefore pray that the culprits may be apprehended and befitting punishment may be awarded as per law of the land at the earliest.

I seek your help and kindly request you to register my FIR in the subject matter. Hope you will do the needful favourable at the earliest.
