

Subject: - First Information Report on attempting to kill and ransacking, looting and torching down all my properties and house.

Sir,

I have the honour to state, that on date 04/05/2023 at around 8:00 pm. Some unidentified group suspected to be the members of Meitei Organisations numbering about 1500 – 2000 people, carrying sophisticated weapon. Forcefully entered our locality Spring Villa Phaipijang Langol under Lamphel Police Station, Imphal West, Manipur.

After looting our properties worth around 95,00,000/- (Ninety Five Lakhs) they vandalised and burn my house.

I, therefore request you to kindly register this case and take the necessary legal action against the culprits according to the law.
