With due respect and regard, I would like to inform you that on 4th May 2023 at around 9:00 pm some valley-based organisations suspected to be volunteers of Arambai Tenggol, Kangleipak Kanba Lup (KKL), Meitei Leepunbroke into my residential quarter at National Games Village, C-58, Zone-2 and looted all my household properties worth approximately around 45(forty five lakhs) only, which includes very important documents, gold ornaments and a sum of Rs.1,50,000/- (one lakh twenty five thousand) only in cash which was kept in the almirah and household electronic gadgets.

I therefore request you to take up necessary legal action regarding the incident.
