The said unidentified groups vandalised and burnt down my shop and looted all the valuable items worth around Rs. 42,00,000/- (Rupees forty-two lakhs) only.

Since the incident, my family fled away and have taken shelter at "Ideal Girls College", Akampat, Imphal-East District, Manipur.

It is therefore prayed that respected sir may kindly initiate and take necessary legal action against the accused persons and the persons who involved in the said inhuman acts and heinous crime committed by the accused persons as per law of the land at the earliest.

I, could not report in time due to prevailing communal crisis in Manipur. Thanking you for your kind co-operation.
