burning down of my shop located at Moreh Ward No. 7 on 3rd May,
2023.

Sir,

I, the undersigned have the honour to state that large number of unknown miscreants belonging to Kuki community with deadly weapons and sophisticated arms including Kuki Militants stormed to all the Meitei inhabited areas of Moreh Town on 3rd May, 2023 at around 4:30 pm. The said unidentified groups vandalised and burnt down my shop and looted all the valuable items worth around Rs. 42,00,000/- (Rupees forty-two lakhs) only.

Since the incident, my family fled away and have taken shelter at "Ideal Girls College", Akampat, Imphal-East District, Manipur.

It is therefore prayed that respected sir may kindly initiate and take necessary legal action against the accused persons and the persons who involved in the said inhuman acts and heinous crime committed by the accused persons as per law of the land at the earliest.

I, could not report in time due to prevailing communal crisis in Manipur.
