vandalized and looted my house and shop named (CHAOKA
STORE) including my shop license located at Kangpokpi Bazar
(Marketing shed) ward no. 6.

There is a delay in filling the application as my family and I
were fleeing for survival and we are currently taking shelter at
Trade and Expo Centre (Zamboikhangrangkhong).

In this connection, I humbly request you to kindly initiate and
take up necessary legal action(s) against the said group.

For this act of kindness, I shall remain ever grateful to you.
