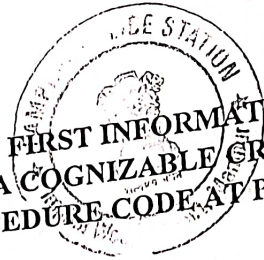

These criminal broke open my gate and looted every valuable property from my house premise looted and vandalized my household property and my Personnel Honda Activa bearing registration no. MN0104843 (Black Colour) was stolen by the said meetei/meitei goons.

Fortunately, me and my family managed to escaped from these criminals who even tried to kill or burn us alive, and now currently taking refuge at Chiaugal, Zenhang Lamka.

Therefore I kindly request you to please take action in this matter and come up with positive solution.
