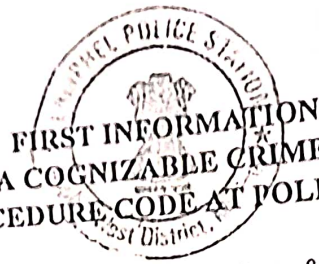

Sir,

I hereby write this letter to draw your attention that in the past few days i.e., on the 4th of May 2023 @ 3:30 pm, the residence of my maternal uncle-in-law Shri. David Tryte aged about 49 years at EFCI mission compound Imphal Aripport road, was attacked by a group of Meetei/Meitei goons.

These criminal broke open the gate and destroy the residential building who looted, vandalized and burnt down the household property along with it one Tata Super Ace a total loss estimated to be at an amount of Rs. 30,00,000/- (Thirty Lakhss) Rupees Only by the said meetei/meitei goons.

Fortunately, Shri David Tryte and his family managed to escaped from these criminals who even tried to kill or burn them alive, and now currently taking refuge at Aizawl Mizoram.

Therefore I kindly request you to please take action in this matter and come up with positive solution.
