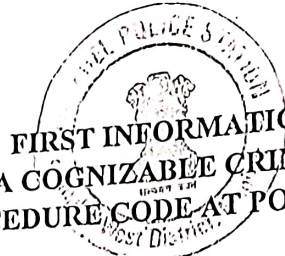

3rd May, 2023 at about 6:15 pm at Yapha Leikai, Langol, Imphal West, P.S. Imphal
West.

Sir,

I, the undersigned, a victim and refugee taking relief / shelter at Belam Veng, Head Quarter, Churachandpur at present have the honour to state the following for your kind intervention and favourable action that, on 3rd May 2023 at around 6:15 pm, unknown mobs from the Meitei community armed with deadly sophisticated weapons viz., automatic guns like Ak-rifles, SLR, machete/ sword, iron rods, etc. came and forcefully vandalized our house and looted our household furniture, Electronic devices and valuable goods which was inside our house, the description of which is detailed hereunder :-

(1) Moveable property – (i) All the domestic goods inside the house.

That, the estimated value of the moveable destroyed and looted is estimated to be worth approximately Rs. 7,25,000/- (Rupees Seven lakh twenty five thousand) only.

Being displaced, I am filing this report at the nearest Police Station and therefore request you to kindly take necessary legal action against the said culprits as per law.
