That, Sir, on 4th May 2023 at around 10 am unknown miscreants suspected to be Ahambai Tengga, Meitei Leeper, Kangleipak Kanba Lup numbering about 400-500 stormed into my campus at National Games Village Quarter No B-295 PO: Lamphel PS: Lamphel Imphal West District, Manipur and looted and destroyed all my properties which is estimated to be about 35 lakhs.
