

Sir,

With due regard, I the undersigned have the honour to state few line for your kind consideration and needful action.

That, on 5/5/2023 at about 3.30 pm, an incident was happened at Sangai prou, near FCI Godown while some loaded trucks of rice were trying to transport at Churchandpur District on guarding by the paramilitary forces. At the same time an agitators numbering about 400/500 had restrained the loaded truck from transporting by pelting stones and stormed towards them in which the suspected armed personnel's had fire several round in order to control the unruly mob. On that firing by the suspected Paramilitary personnel's my brother namely-Oinam Kamandar Singh, aged about 28 yrs S/o Oinam Tomba Singh of Chingmei Awang Leikai, Moirang Sub-Division, Bishnupur District A/P staying at the rented house of Oinam Naobi Singh of Sagolband Moirang Hanuba received bullet injury on his right lower abdomen and immediately evacuated at Asian Hospital, Kwakeithel for medical treatment. Now, he is under critical condition.

Therefore, I request you to kindly take necessary action on the bullet injury made by the armed personnel's. Thanking you for your kind co-operation.
