Lamphel, Imphal Wast, Manipur.

These criminal broke open the gate and destroy, vandalized, looted and burnt all my household item/assets from within my rented room mentioned herein-above including one scooty Fascino of Yamaha make bearing Reg. No. MN06S B7159, a total loss estimated to be at an an amount of Rs. 15,00,000/- (Rupees Fifteen Lakh) was lost due to the act/unlawful activities of said armed meetei/meitei radicals.

Fortunately, me and my family members managed to escaped from these criminals who even tried to kill or burn them alive, and now currently taking refuge at Churachandpur.

Therefore I kindly request you to please take action in this matter and come up with positive solution.
