I hereby write this letter to draw your attention that in the past few days i.e., on the 4th of May 2023 @ 07:00 pm, the quarter allotted to Smt. Lhingneithem Haokip W/o 'Shri. Thangkhohao Haokip, Type-III/D-23 Quarter situated at Langol, P.S. Lamphel, Imphal West- 795004, was attacked by a group of armed Meetei/Meitei radicals.

These criminal broke open the gate and a total loss estimated to be at an amount of Rs. 15,50,000/- (Rupees Fifteen Lakhs Fifty Thousand) only comprising of my household item and personnel assets was looted, vandalized and gutted/burnt down by the said armed meetei/meitei radicals.

Fortunately, she and her family managed to escaped from these criminals who even tried to kill or burn them alive, and now currently taking refuge at Aizawl, Mizoram.

Therefore I kindly request you to please take action in this matter and come up with positive solution.
