Sir,

I hereby write this letter to draw your attention that in the past few days i.e., on the 3rd of May 2023 @ 09:00 pm, the quarter allotted in my name John Chinthang Hangsing aged about 36 years S/o Shri. H Thangzatuan, B/154, Zone-IV, situated at National Game Village, P.S. Lamphel, Imphal West- 795004, was attacked by a group of armed Meetei/Meitei radicals.

These criminal broke open the gate and a total loss estimated to be at an amount of Rs. 43,35,000/- (Rupees Forty Three Lakh Thirty Five Thousand) only comprising of my household item and personnel assets including five vehicles:

- 1) Mahindra TUV 300 Bearing Reg. No. MN01AK 6125;
- 2) Maruti Wagon R Bearing Reg. No. MN01AG 1937;
- 3) Hyundai i10 Grand Bearing Reg. No. MN01AW 7850;
- 4) TVS Jupiter Bearing Reg. No. MN01AJ 3248;
- 5) Royal Enfield Bearing Reg. No. MN01U 2241;

was looted, vandalized and gutted/burnt down by the said armed meetei/meitei radicals.

Fortunately, me and my family managed to escaped from these criminals who even tried to kill or burn them alive, and now currently taking refuge at New Lamka, College Veng.

Therefore I kindly request you to please take action in this matter and come up with positive solution.
