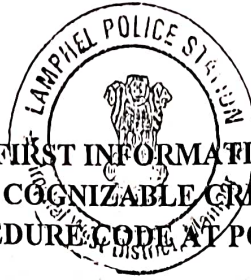

At the very outset, I would like to draw fewline for your information that due to the present situation of class between Tribal and Valley base Meitei/Meeitei, my vehicle Car-Ford Endeavour was push out from our resident at open place and burnt down. On the same day I along with my wife and daughter run out from our resident for our life.

It is requested to your good office to make entry of my report a Zero F.I.R and take action against the perpetrator and also issue me the copy of the said report for my reference in future on the burning down of my said vehicle.
