With due respect, I have the honour to state a few lines
of consideration and necessary action. That on 4th May, 2023
at around 7pm that an unknown miscreants belonging to
Ariambai Penggal, Meitei Leepun, kangleipak kanba Lep numbering
about 200-300 stormed into my campus and destroyed, looted
all properties in my house which is located at National
Games Village Quarter Number C/40, Zone II PO: Lamphel,
PS: Lamphel, Imphal West District, Manipur. The approximate
value of properties lost/damaged is estimated to be about
40 lakhs.

I could not report the incident to my concerned
Police Station as well as in time due to the prevailing
law and order situation in the state.
