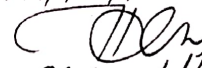

I have an honour to state that unfortunately
our Church was damaged and burnt down almost
completely by a mob who were more than 1000
at 11:00 am on 04/05/2023 during the ongoing
ethnic clashes and violence spreads throughout
in Manipur. As an outcome of the violence, our
entire Church building furniture, sound system, musi
system and Church quarter properties was burnt
down almost completely.

I have also heard that some believers had been threatened but so far I haven't received it. If any such incident occur in future, I request the higher authority to take the matter seriously and take necessary action please to protect the minority Christian. Recently, the State Government has announced the compensation of the damage and loss of properties. I request the higher authority to sore out the way to get the compensation as required.

Again, I request the Officer-in-Charge to lodge FIR against the destruction and damage, and to take the necessary action please.
