

With due respect, I would like to report a cognizable offence carried out against me and my family on 04th May around 10:30 AM. Wherein, a large gathering mob of Meitei Community conspired and instigated by Meitei Leepun & Arambai Tenggol of Valley based CSO's attacked on my/our family and started vandalizing, ransacking and burnt down my/our House, Langel Housing Complex, Imphal rendering me in a state of homelessness. Fearing to lose of our lives and being in a state of vulnerability, along with my family members numbering 1 (male) 2 (female) had fled and now taking refuge and shelter at the resident of /Relief Centre JNV, Tuinam.

That, the assets/properties and damages were estimated to Rs 10 lakhs.

I, therefore, seek your kind intervention to register an FIR against the perpetrators and abators for their heinous acts carried out against me and my family.
