Fearing to lose of our lives and being in a state of vulnerability, I, along with my family members numbering 1 (male) 2 (female) had fled and now taking refuge and shelter at the resident of /Relief Centre TNV, Twinam

That, the assets/properties and damages were estimated to Rs 10 Lakhs.

I, therefore, seek your kind intervention to register an FIR against the perpetrators and abators for their heinous acts carried out against me and my family.
