Sir,

I am a government employee serving as Assistant Sub-Inspector (ASI) being EIN No. 014180 of Manipur Police Department, Government of Manipur.

I was allocated a Quarter being Qtr No. Type-D 134, Zone-2, National Games village, PO & PS-Lamphelpat, Imphal West, 795004. Wherein, I also constructed a Pucca House for residential at Phainom Veng, National Games Village near KBC Church.

I would like to inform and register a cognizable offence carried out against me at my residential house as well as at the allocated Quarter as aforementioned above by Meitei Miscreants on the 4th day of May, 2023 around 7:00 AM, who were armed with sophisticated Pistol, Machette and Knife, whom were suspected to be instigated and abated by Meitei Leepun and Arambai Tenggol of Valley based CSO's.

Due to such attack and being in state of vulnerable. Fearing to lose our lives, I along with my family comprise of Male-4 & Female- 2 had fled from our resident/home.

As such, we have been taking shelter at the resident of my father in law namely Thangjakhup Lungdim of Old Gelmol near Post Office Tuinom, Churachandpur District.

On inquiry, Our Private residential house was ransacked, torched and burnt down to ground. Similarly, allocated quarter i.e. Type-D 134 of National Games village was ransacked and looted. Hence, I along with my family members were render to a state of homelessness with no place to accommodate me and my families

I, therefore, seek your kind intervention to register a complaint (Zero FIR) against the culprit and instigator who abate to carried out such heinous attack against me and my family for the end of justice.
