



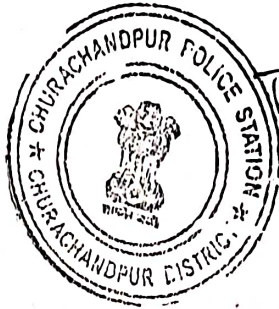

With due respect, I the undersigned would like to make a report to your good office about vandalised, burning down of my building and looting of properties (Movable) from my resident at Lamphel Super Market H/No 56, Imphal West, P.O & P.S- Lamphel & District- Imphal West on 28-05-2023 at 5:00 pm by a group of Meeitei/Meitei's numbering 500 to 600 along with women.

At the very outset, I would like to draw fewline for your information that due to the present situation of ethnic class between Tribal and Valley base Meitei/Meeitei from 03-05-2023, on dated 28-05-2023 in the evening the lock of my resident was destroyed by a group of Meeitei/Meitei's numbering 500 to 600 along with women, they vandalized, burnt down my house and looted all of my properties (Movable) worth Rs.17,16,4000/- (Rupees One Crore Seventy one lakh Sixty four Thousand) on the said day.

It is requested to your good office to make entry of my report a Zero F.I.R and take action against the perpetrator as per Law and also issue me the copy of the said report for my reference in future.
