



Between Lamne Super Market, POA Complex, H.No-36, My residence
located at Lamne Super Market, POA Complex, H.No-36
was attacked by a Group of Meeitei/Meitei's goons numbering 500 to 1,000 men.

These criminals broke open my gate(s) and looted every valuable property from my
Owned/Rental House, and premises worth Rupees 3,931,000/- (approx..) and they burnt
down all the remaining things. + 400,000/-

Fortunately, me and my family managed to escaped from these criminals who even tried
to kill or burn us alive.

Therefore, with utmost Respect I request you to take strong actions against the
perpetrators by **registering an FIR** under relevant sections of the Indian Penal Codes.
