Subject:- Report on looting, vandalism and burning of properties at government
quarter.

Sir,

I hereby write this letter to draw your attention that in the past few days i.e., on the
4th of May 2023 @ 07:00 pm, the residence quarter allotted in my name Mr T.
Lianzathang at Qtr. No. Type II, C/30 situated at Lamphelpat, Imphal West- 795004,
was attacked by a group of armed Meetei/Meitei radicals.

These criminal broke open the gate and a total loss estimated to be at an amount of
Rs. 15,00,000/- (Rupees Fifteen Lakhs) only comprising of my household item and
personnel assets including the government quarter to which I was allotted was looted,
vandalized and gutted/burnt down by the said armed meetei/meitei radicals.

Fortunately, me and my family managed to escaped from these criminals who
even tried to kill or burn us alive, and now currently taking refuge at Churachandpur.

Therefore I kindly request you to please take action in this matter and come up
with positive solution.
