

These criminal broke open the gate and a total loss estimated to be at an amount of Rs. 10,00,000/- (Rupees Ten Lakhs) only comprising of my household item and personnel assets with the above mentioned allotted quarter was looted, vandalized and gutted/burnt down by the said armed meetei/meitei radicals.

Fortunately, me and my family managed to escaped from these criminals who even tried to kill or burn us alive, and now currently taking refuge at Churachandpur.

Therefore I kindly request you to please take action in this matter and come up, sh with positive solution.
