I am to bring to your notice that on 3rd May 2023 between 5:00pm to 7:00pm, my Quarter located at Langol Housing Complex, Imphal West was attacked by a group of Meitei Goons.

The said goons broke my gate, destroyed my Maruti Van bearing regd. No. MN04A6175 and TVS Heavy Duty bearing regd. No. MN01AE4105 and entered my house by forced and destroyed my household properties with an estimated cost of Rs. 30,00,000/- (30 lakhs approx.)

Fortunately, I myself and my family managed to escaped from the culprits.

Therefore, with utmost respect, I request you to take strong action against the perpetrator by registering an FIR under relevant section of the Indian Penal Code.
