These criminal broke open the gate and a total loss estimated to be at an amount of Rs. 17,44,000/- (Rupees Sevnteen Lakhs Forty Four Thousand) only comprising of my household item and personnel assets was looted, vandalized and gutted/burnt down by the said armed meetei/meitei radicals.

Fortunately, she and her family members managed to escaped from these criminals who even tried to kill or burn them alive, and now currently taking refuge at Shillong, Meghalaya.

Therefore I kindly request you to please take action in this matter and come up with positive solution.
