Amidst the criminal activities, I along with my family members managed to escape because of Divine Grace and fled to 1st Manipur Rifle (MR) Mantripukri for our safety and finally left the camp on 8th May 2023.

Therefore, I request you to kindly take strong actions against the perpetrators by registering Zero FIR under elevant criminal sections of Indian Penal Codes.
