Sir,

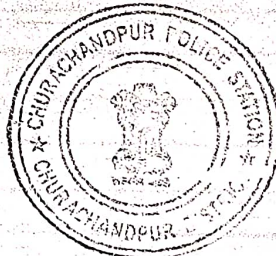
I am to bring to your notice that on the 4th May 2023

*Quarter* These criminals broke open my gate(s) and looted every valuable property from my  
~~Owned/Rental House~~, and premises worth Rupees 3,40,000..... (approx..) and they burnt  
down all the remaining things. Two of my Vehicles (Bike & Scooty)

Fortunately, me and my family managed to escaped from these criminals who even tried  
to kill or burn us alive.

Therefore, with utmost Respect I request you to take strong actions against the  
perpetrators by **registering an FIR** under relevant sections of the Indian Penal Codes.
