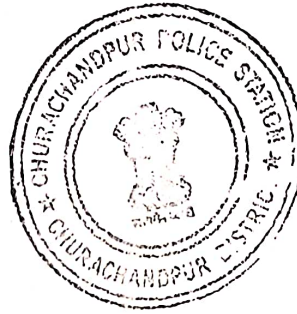

Subject:- Report on looting, vandalism and burning of properties at government quarter.

Sir,

I hereby write this letter to draw your attention that in the past few days i.e., on the 4<sup>th</sup> of May 2023 @ 07:00 pm, the residence quarter allotted in my name of Mrs. Hatting Khongsai at Langol Housing Complex Type-III E/63, situated at Langol, Imphal West- 795004, was attacked by a group of armed Meetei/Meitei radicals:

These criminal broke open the gate and a total loss estimated to be at an amount of Rs. 8,00,000/- (Rupees Eight Lakhs) only comprising of my household item and personnel assets was destroyed/looted, vandalized and gutted/burnt down by the said armed meetei/meitei radicals.

Fortunately, me and my family managed to escaped from these criminals who even tried to kill or burn us alive, and now currently taking refuge at Churachandpur.

Therefore I kindly request you to please take action in this matter and come up with positive solution.
