I would like to inform and register a cognizable offence carried out against me on the 3rd day of May, 2023 at around 6:00 pm at my resident i.e. National Games Village, bearing Patta No. 18 (Old) / 1/3906 (New) by Meitei community, who were armed with sophisticated Pistol, Machette and Knife, whom were suspected to be instigated and abated by Meitei Leepun and Arambai Tenggol of Valley based CSO's.

Due to such attack and being in state of vulnerable. Fearing to lose our lives, I along with my families had fled from our resident/home.

As such, I along with my wife have been temporary taking refuge at my younger brother namely Kailun Khongsai of Tuibong, Churachandpur.

On inquiry, my resident was ransacked, torched and burnt down. Domestic animals were killed and taken. Similarly, properties were looted and taken away rendering me in a state of homeless person with no place to accommodate me and my families.

Therefore, I seek your kind intervention to register an FIR against the culprit and instigator who abate to carried out such heinous attack against me and my family for the end of justice.
