I am a government employee serving as Rifleman bearing Rfn. No. 05197185 in 5<sup>th</sup> Battallion (Khongjaron, Tamenglong District) Manipur Rifle, Government of Manipur presently attached to Rear (DIG Range -II) Thoubal. I stayed at the Quarter of my mother namely Hatlhing Dounge, Member of Autonomous District Council, Tamenglong at National Games Village, Imphal being Qtr No. A-2, Zone-IV, PO-Lamphel, PS-Lamphel, District- Imphal West, 795004.

I would like to inform and register a cognizable offence carried out against me on the 3<sup>rd</sup> day of May, 2023 at around 7:00 am by Meitei community, who were armed with sophisticated Pistol, Machette and Knife, whom were suspected to be instigated and abated by Meitei Leepun and Arambai Tenggol of Valley based CSO's.

Due to such attack and being in state of vulnerable. Fearing to lose our lives, I along with my families had fled from our resident/home.

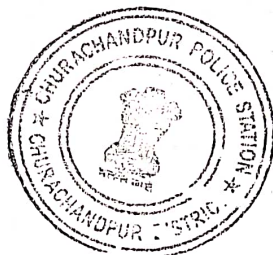
As such, I along with my wife have been settling taking refuge at the resident of my Mothers-in-law at Tuibong, Churachandpur.

On inquiry, Our quarter was ransacked. Domestic animals were killed and taken. Similarly, properties were looted and taken away rendering me in a state of homeless person with no place to accommodate me and my families.

Therefore, I seek your kind intervention to register an FIR against the culprit and instigator who abate to carried out such heinous attack against me and my family for the end of justice.
